Guest Speaker: Leanne Langston, Volunteer Coordinator/Media Outreach Specialist, A1AA Ombudsman Program

Leanne outlined the Volunteer Ombudsman Program. The program includes 30-35 hours of training and a background check (fingerprinting) before receiving certification from the State. Certified Ombudsman work from Crescent City to Garberville, meeting residents in long-term care (LTC) facilities and inspecting the facilities. The monthly commitment for volunteers is a minimum of 10-12 hours. Ombudsman are the advocates for seniors living in LTC facilities. While they cannot give legal advice, they can witness an Advanced Health Care Directive, investigate and resolve complaints, and work to improve the quality of life and the rights of residents living in LTC facilities.
